A3242: Deer poaching, deer control activities; check-off donation of venison, authorizes issuance of multi-species depredation killing permit for wildlife control on farmland.
A1822: removes a provision under current law that requires the court to declare a dog to be declared potentially dangerous if the dog has been trained, tormented, badgered, baited, or encouraged to engage in unprovoked attacks on domestic animals.
S3146: Establishes owning or possessing animal fighting or dog fighting paraphernalia as crime of third degree; establishes civil animal cruelty penalties therefor.
A3044: An Act providing for the licensing of pet groomers and the registration of certain businesses, designated as "Bijou's Law."
S1093: "Nosey's Law"; prohibits use of wild or exotic animals in traveling animal acts.
A4845: Prohibits certain possession, sale, trade, distribution, or offering for sale of shark fins.
A781: Establishes process for recovering cost of caring for animals involved in animal cruelty violations.
A3110: Bans manufacture, sale, possession, importation, transportation, or use of certain traps.
A2318: Provides immunity from civil and criminal liability for rescue of animal from motor vehicle under inhumane conditions.
